***Re: In Re: Diet Drugs Litigation, Seventh Amendment***

Dear Claimant:

The purpose of this letter is to inform you about recent changes in the Fund Administrator's policies governing requests for "Second Reviews" under Section XV.M of the Seventh Amendment.

After consultation with Class Counsel, Members of the Seventh Amendment Liaison Committee and others, we have decided to reduce the fee charged where a Second Medical Review is requested for a Claim after the Class Member receives a Report on Initial Medical Review of the claim. The new reduced fee will be \$1,000.00 instead of the current charge of \$2,500.00. Therefore, in order to obtain a Second Medical Review under the terms of the Seventh Amendment, a Category One Class Member must make a timely request for a Second Review accompanied by a payment in the amount of \$1,000.00. Also, you should be aware that we will begin referring claims for Second Medical Reviews before all of the Initial Medical Reviews have been completed. However, until all Initial Medical Reviews are completed, we will limit the number of Second Medical Reviews to no more than 20% of the total number of claims referred for Medical Review per month.

To the extent that you have already received the form entitled "Request for Second Review" in connection with the Report on Initial Medical Review for a given claim, you may consider the form to be amended by this letter. In addition, if the time to make a request for a Second Medical Review has expired for any Category One Class Member as of February 15, 2006 and that Class Member wants to request a Second Medical Review on account of the fee reduction announced in this letter, such a request will be considered timely if made by March 15, 2006 so long as it is accompanied by payment of the \$1,000.00 fee.

Finally, we use this opportunity to announce that Class Counsel and the Seventh Amendment Liaison Committee are sponsoring a conference concerning the status of the Seventh Amendment claims process on March 2, 2006. Details concerning this conference are contained in the letter from Michael D. Fishbein which is enclosed.


We are aware that as the results of "Initial Reviews" of Category One Claims are disseminated by the Seventh Amendment's Fund Administrator there have been an increasing number of questions concerning the manner in which claims are referred for Medical Review, the nature of that review, the training afforded to Participating Physicians by the Medical Review Coordinating Committee ("MRCC"), the quality assurance measures adopted by the MRCC, the overall "pass rate" for Seventh Amendment Claims, and the like.
